SUMMARY OF STATE VA BENEFITS

Local Benefits Provided to Virgin Islands Veterans "Only"

Definition of Virgin Islands Veteran - Veterans who were domiciliaries of the Virgin Islands at the time of death, and who entered the armed services in the Virgin Islands or who were domiciliaries of the Virgin Islands but entered the armed services in another jurisdiction while temporarily residing in that jurisdiction.

- 1. Home / land loan (when available) Max amount of \$220,000.00 at a low rate of 3.5%.
- 2. FREE <u>Tuition</u> for attendance at UVI, all fees are paid by the Veteran. In addition, Virgin Islands Veterans shall be permitted to attend, without fee or charge of any kind, UVI CELL (Community Engagement & Lifelong Learning) or any academic or career and technical course conducted by the Department of Education in the US Virgin Islands, whether held in the day or night. (See OVA Policy #2)
- 3. A maximum of \$5,000.00 is **reimbursed** for Burial Expenses of Virgin Islands Veterans (See OVA Policy #4).
- 4. Opportunity to acquire a Taxi Medallion through the annual VI Taxi Medallion auction. (See OVA Policy #5)
- 5. Designation of "Veteran" on Driver's License or State I.D. issued by the Bureau of Motor Vehicles (BMV). (Includes VI National Guard Retirees w/20+ years)

Local Benefits Provided to Veterans Residing in the USVI

- 6. A FREE Burial Plot in local cemeteries having a designated section for Veterans. A spouse, or minor child, and under certain conditions an unmarried adult child is also eligible for burial in conjunction with the Veteran.
- 7. Homestead Tax Exemption of Real Property Tax Bill is offered to Veterans or the widowed spouse of a Veteran who occupies their primary home. (See OVA Policy #6)
- 8. Any Veteran of the Armed Services of the United States who has a service-related disability rating determined by the U.S. Veterans Administration entitling them to receive compensation for **permanent and total disability** is exempt from the payment of all real property taxes levied by the Tax Assessor against the disabled Veteran's homestead.
- 9. 10-Points Preference added to Veteran's score on Local civil Service Examinations and 15-Points for Disabled Veterans. A disabled Veteran is a Veteran with a serviceconnected disability currently rated at 0% or more. The widow or spouse of a disabled veteran shall be entitled to the same benefit granted to disabled veterans under this subsection.
- 10. FREE Emergency Ambulance Service to all Veterans residing in the US Virgin Islands.
- 11. 100% reimbursement of off island airfare for non service-connected Veterans with a VA medical appointment at the closest VA medical facility. (See OVA Policy #3)
- 12. Up to 3 FREE sets of Veterans License Plates; however, only one disabled licensed plate per eligible Veteran. (Fees associated with the registration must be paid by the Veteran).
- 13. Disabled License Plate for Veterans having a "Permanent and Total" disability designation based on military service and documented on their Benefit Summary Letter obtained from the Veterans Benefit Administration @ 1(800) 827-1000.
